In accordance with *Chapter 119* of the Revised Code (R.C.), the Director of the Ohio Department of Health announces a Public Hearing at the date and time listed above to hear comments regarding the following action:

Ohio Revised Code (O.A.C.) Chapter 3717:1-37 – Physical Protection of Radioactive Material.

The proposed rules are under review as part of the statutory 5-year rule review process. They include physical protection guidelines for any person licensed to possess or transport of radioactive materials. The requirements ensure security of the specified radioactive materials from theft or diversion and address the access, use, transfer, and transportation of the radioactive material.

Information regarding rule package proposed:

This Ohio Department of Health (Department) rule package consists of 31 rules (9 no change rules, and 22 amended rules and the public comment period was open through January 2nd, 2019.

The Department presented the draft rules to the Radioactive Material Committee (RMC) which is comprised of experts in the field of radiation safety who represent stakeholders in industrial, academic, medical, and research facilities, and the RMC assisted the Department staff in reviewing the rules. The RMC approved the rules for public comment on July 10th, 2018. During the public comment period there were no comments.

The draft rules will affect approximately 67 licensees in the State of Ohio and an additional 28 entities that are licensed by other states but authorized to operate in Ohio. The impact of these rules is manifested in the cost and time for licensees to develop and maintain security programs and compliance with the draft rules. These security programs and procedures are estimated to take 40 hours to create and 10 hours per month to ensure compliance.

Ohio Revised Code (O.A.C.) Chapter 3701-82 – Lead Training Programs.

The proposed rules are under review as part of the statutory 5-year rule review process. The rules outline the application requirements and standards of conduct for environmental lead analytical laboratories, clinical lead laboratories, and lead training courses in Ohio. The rules are being amended to update references and clarify the requirement for applicants to include third-party proficiency testing provider information in applications submitted for approval of a clinical lead laboratory.

Information regarding rule package proposed:

This rule package consists two amended rules and five 'no change' rules submitted by the Ohio Department of Health (Department) as part of the statutorily required five-year review. The rule package was submitted to the CSI Office on May 10, 2019, and the comment period remained open until June 9, 2019. No comments were received during this time.

NOTICE OF PUBLIC RULES HEARING

As part of early stakeholder outreach the Department notified key stakeholders of the proposed rule, including lead laboratories, lead training providers, local health departments, and environmental health organizations. The rule package reflects all feedback provided during early stakeholder outreach. The rules impact environmental laboratories seeking to perform environmental analysis of samples collected from properties in the state, clinical laboratories seeking to perform human sample analysis from residents of the state, and approved lead training course providers.

Hearing and Contact Information:

At the hearing, people affected by the proposed action may appear and be heard in person or accompanied by an attorney. They may present their positions, arguments, or contentions orally or in writing; may offer witnesses; and may present evidence showing that the proposed rule, if adopted or effectuated, will be unreasonable or unlawful.
