Pursuant to Ohio Administrative Code 5501-1-01 and Ohio Revised Code Section 119.03, notice is hereby given that the Ohio Department of Transportation intends to consider rescission of the rules identified below and of a public hearing thereon.

5501:1-10-04 "Construction within jurisdictional airspace" – Rescind (don't need the language, it is in RC 4561.31)
5501:1-10-05 "Standards for determining obstructions and navigable airspace" – Rescind (renumbered as 5501:1-08-05 and as 5501:1-08-06 creating a separate rule for waivers)
5501:1-10-06 "Permit application content" – Rescind (amended and renumbered as 5501:1-8-03)
5501:1-10-07 "Review of submitted application" – Rescind (content moved into 5501:1-08-03)
5501:1-10-08 "Aeronautical study" – Rescind (amended and renumbered as 5501:1-08-04)
5501:1-10-09 "Approval and denial of applications; Application amendments" – Rescind (amended and renumbered as 5501:1-08-07)
5501:1-10-10 "Marking and lighting obstruction standards" – Rescind (rule not needed, covered under statute)
5501:1-10-11 "Abandonment of a permitted structure" – Rescind (amended and renumbered as 5501:1-08-08)
5501:1-10-12 "Objects of natural growth" – Rescind (rule not needed, covered under other rules and statute)
5501:1-10-13 "Enforcement procedures; violations" – Rescind (amended and renumbered as 5501:1-08-09)
remits of Certification

The Ohio Department of Transportation shall hold a public hearing on the rescinded rules at the date, time, and location listed at the top of this notice. Both oral and written testimony will be taken at the public hearing. Additionally, written comments submitted or postmarked no later than the date of the public hearing will be treated as testimony.
