- Administrative rules 1501:46-1-02, 1501:46-2-03, 1501:46-2-31, 1501:46-2-39, 1501:46-2-41, 1501:46-3-10, 1501:46-3-11, 1501:46-3-13, 1501:46-3-30, 1501:46-3-34, 1501:46-7-02, 1501:46-7-07, 1501:46-7-08, 1501:46-7-11, 1501:46-7-12, 1501:46-9-01, 1501:46-9-02, 1501:46-9-07, 1501:46-9-08, 1501:46-12-09, 1501:46-12-18, 1501:46-13-01, 1501:46-13-05, 1501:46-15-17 and 1501:47-7-17 are being amended to update the references to the Revised Code that are implemented or amplified by the rule and references that provide the Division of Parks and Watercraft with the authority to adopt rules; no changes to the existing rule language are being proposed.

- Administrative rule 1501:46-15-05 is being amended to update the references to the Revised Code that are implemented or amplified by the rule and references that provide the Division of Parks and Watercraft with the authority to adopt rules as well as incorporate Division of Wildlife language prohibiting the 'baiting' of wildlife for hunting on state park lands
- Administrative rule 1501:46-15-08 is being amended to update the references to the Revised Code that are implemented or amplified by the rule and references that provide the Division of Parks and Watercraft with the authority to adopt rules as well as add Jesse Owen's State park to areas where public hunting is permitted.
- Administrative rule 1501:47-1-07.1 is being amended to expand authority to authorized registration agents to issue contingent registration decals (currently restricted to only Natural Resource Officers or the chief)
- Administrative rule 1501:47-7-09 is being amended to codify existing activity zones adopted under the provisions of ORC 1547.08 including delineating such lake zones with GPS coordinates for clarification, remove the prohibition of towed watersports at any time in specific areas, and allows for such activities during designated timeframes,
- Administrative rule 1501:17-11-07 is being rescinded because the position of preserve officer no longer exists within the Department of Natural Resources and the provisions of the rule are addressed within Chapter 2921 of the Revised Code.
- Administrative rule 1501:46-12-08 is being rescinded because it duplicates provisions in the Administrative rule 1501:47-1-13.

A public hearing on the proposed amendments, adoptions, and rescission of these rules will be held at 2:00 p.m. on Thursday, March 26<sup>th</sup>, 2020 in the Poverty Room on the first floor of building C at the Department of Natural Resources located at 2045 Morse Road in Columbus, Ohio. At the public hearing, any person affected by these rule proposals may appear and be heard in person, or by an attorney, or both, and may present testimony, orally or in writing, and present evidence tending to show that these rules, if adopted, amended, or rescinded, will be unreasonable or unlawful.
