The following rules are being rescinded:

123:2-15-02	Bid notifications and specifications concerning minority business enterprises.
123:2-15-03	Minority set aside review board established.
123:2-15-04	Application to the minority set aside review board.
123:2-15-05	Minority set aside review board procedures for emergency contracts.
123:2-15-06	Minority set aside review board notice of meetings.

These rules are being rescinded because the authorizing legislation has since been repealed. The minority set aside review board was created by former R.C. 123.151(C)(4), and DAS was authorized to adopt rules concerning the board by former R.C. 123.151(C)(5). These provisions were repealed in 2004 by HB 216 of the 125th General Assembly, and the Minority Set Aside Review Board no longer exists.
