PUBLIC NOTICE

The Ohio State Racing Commission will hold a public hearing for the purpose of accepting testimony on the proposed amended rule package containing rules found in Chapter 5 of the Ohio Administrative Code.

These rules discuss permit holders' requirements in Standardbred horse racing. These rules were reviewed in accordance with the requirement of Ohio Revised Code 119.03 and have proposed as follows:

- Ohio Administrative Code 3769-5-07 titled Official Program. This rule is being amended to require additional information for the program.
- Ohio Administrative Code 3769-5-20 titled Emergency authority. This rule is being amended to allow statement of partnerships can be given to the racing secretary by fax or email.
- Ohio Administrative Code 3769-5-27 titled Registration with associations. This rule is being amended to remove microchip and add digital tattoo.
- Ohio Administrative Code 3769-5-36 titled Closing of stake races. This rule is being amended to allow nominations and declarations to be made by email, fax, and regular mail.
- Ohio Administrative Code 3769-5-47 titled Weight for age. This rule is being rescinded because this weight system for jockeys is outdated.
- Ohio Administrative Code 3769-5-50 titled. Filly allowance. This rule is being rescinded because this weight system for jockeys is outdated.
- Ohio Administrative Code 3769-5-51 titled Weight. This rule is being amended to modernize the jockey weight system.
- Ohio Administrative Code 3769-5-54 titled. Apprentice jockey allowances. This rule is being rescinded because this weight system for jockeys is outdated.
