In accordance with Chapter 119 of the Revised Code (R.C.), the Director of the Ohio Department of Health announces a Public Hearing at the date and time listed above to hear comments regarding the following action:

### Ohio Revised Code (O.A.C.) Chapter 3701-46-01, -02 – Disposition of Fetal Remains from a Surgical **Abortion**

The rules set forth in Chapter 3701-46 of the Ohio Administrative Code ("OAC") establish requirements for facilities that perform surgical abortions and the disposition of fetal remains. Specifically, the rules require the Department to create a form informing a pregnant woman of her right to determine whether final disposition of remains will be by interment or cremation and the location of the final disposition, and a supplemental form allowing her to make those determinations. The second rule requires the Department to create a consent form to be used if a pregnant woman is under 18 years of age, which is not required to be used under certain statutory authorizations or court orders.

#### Information regarding rule package proposed:

This rule package consists of two new rules. The draft rules were submitted to the CSI Office on August 19, 2021, and the public comment period was open through September 20, 2021.

Ohio Administrative Code (OAC) Chapter 3701-46 impact facilities that perform surgical abortions. Impacts may include the cost of providing required forms to patients, at a paper cost of \$4.87 to \$6.99 per 500 forms. Impacts may also include costs to print these forms including \$15 to \$100 for printer ink cartridges, and \$14 to \$300 for copier ink. Furthermore, impacted facilities may incur administrative costs for printing and distribution time and the time necessary for physicians to sign required forms, estimated at 15 minutes each. The Department states that the proposed rules are required to fulfill its statutory obligations in ORC 3726.14.
