Public Notice Proposed Rulemaking Governing for Ohio Administrative Code (OAC) Chapter 3745-20 "Asbestos Emission Control" and OAC Chapter 3745-22 "Asbestos Licensing, Certification, and Course Management" Amended Rule

Notice is hereby given that the Director of Environmental Protection, under the authority of Sections 3704.03 of the Ohio Revised Code and in accordance with Chapter 119, proposes to file amended and no-change rules in Ohio Administrative Code (OAC) Chapters 3745-20 "Asbestos Emission Control" and 3745-22 "Asbestos Licensing, Certification, and Course Management".

These rules address control of emissions of asbestos during asbestos hazard abatement activities, licensing of asbestos hazard abatement contractors and asbestos training providers, certification of individuals participating in asbestos hazard abatement activities.

The purpose of the revisions to these rules are primarily minor for clarification, to fix typos and LSC formatting errors and to remove unnecessary rule restriction language.

The public comment period will run until April 19, 2024. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rules on April 19, 2024, at 11:15am. The in-person hearing will be at the same time and date and will be located at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. During the hearing, the public may submit written comments on the record about the proposed rules if participating virtually and verbally if participating in person.

Prior registration will ensure that registrants are heard ahead of those individuals who register at the hearing. Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rule making.
