This rule is proposed to clarify the prohibition contained in R.C. 2915.093(D) banning charitable instant bingo organizations from conducting instant bingo other than at a bingo session at certain locations.

The rule incorporates the statutory language of R.C. 2915.093(D), but clarifies that no charitable instant bingo organization shall conduct instant bingo other than at a bingo session at a location where primary source of retail income from all commercial activity at that location is the sale of instant bingo tickets other than at a bingo session.
