This rule outlines the minimum training and instructor qualifications for the continuing professional training program. In addition, the continuing professional training shall be conducted in a program that is approved by the Executive Director of OPOTA and shall address matters directly related to the duties and responsibilities of a peace office or trooper. The rule also states the the training shall serve a recognized law enforcement purpose and the primary objective of the training shall be to improve a participants competence as a peace officer or trooper. The rule also states that individuals who are commission-certified and who have allowed such certification to lapse are not qualified to teach continuing professional training. In addition, the rule states that continuing professional training does not include annual in-service firearms requalification nor does it include any form of training received elsewhere mandated for peace officers by the General Assembly or the Attorney General.
