This rule simply states that if any peace officer or trooper who in any calendar year fails to comply with the continuing professional training requirements set forth in the Ohio Administrative Code section 109:2-18-01 through 109:2-18-07 shall cease carrying a firearm and shall cease performing the functions of a peace officer or trooper until evidence of compliance is filed with the Executive Director of OPOTA. This rule does not apply to peace officers or troopers for whom an extension has been granted by the Executive Director. Also, the decisions of the Executive Director are subject to the appeals process of section 119 of the Revised Code.

The estimated cost of complaince with this rule will vary by appointing authority. There are 984 agencies in the State that appoint peace officers and Ohio State Highway Patrol Troopers, the cost of compliance will necessarily be different for each since it will depend on how many of their appointed peace officers might fail to comply with the continuing professional training in a calendar year. The peace officer can be granted an extension to complete the required training upon making a written request explaining the emergency circumstances for the extension to the Executive Director of OPOTA.
