This rule is necessary to create a process to validate the occurrence of the InvestOhio Program investments.

This rules sets forth the process in which applicants must submit evidence of

investments and and the associated expenditures, as well as information about the ownership of Eligible Investor groups to Development. Applicants that do not follow these requirements will be disqualified from do not follow the requirements will be disqualified from the InvestOhio Program.

During the rule review period, it was suggested that additional flexibility was needed for the validation of qualifying investments. Rather than begin the thirty day period on the effective date of the InvestOhio rules, the thirty day period will begin when the Director begins to process the electronic evidence of investment and allowed expenditures. The Director will announce the first date when the department will accept evidence of investment and allowed expenditures. These may not be the same dates and will depend on the phased implementation of the electronic data system being created to manage the program.

In addition, a division F concerning the subversion of the purpose of the InvestOhio Program was deleted from this rule 5 and similar language was placed in rule 10

which covers disqualification of the small business investment certificates.

Development projects having one full-time staff to administer the InvestOhio Program. The salary, fringe and associated indirect costs as well as an allocation for information technology systems development and a small allocation for travel and training activities support an annual program budget of \$200,000. The Director of Development may issue up to \$10 million of Small Business Investment Certificates during a fiscal biennium. These certificates result in a tax credit for Eligible Investors. The \$10 million in possible tax credits are not an expenditure of Development; however the tax credits will impact state tax revenues.

14. Identify the appropriation (by line item etc.) that authorizes each expenditure necessitated by the proposed rule:

Development will use the GRF 195415 line item for the current biennium to pay the projected costs of the administrative expenditures and the M087 195435 line item for the information technology systems development costs.

The cost of compliance to directly affected persons includes the costs of application, accounting, reporting and maintenance of records. Such costs are expected to be negligible compared to the tax credit benefits available to the Eligible Investor through the InvestOhio Program. Actual costs will vary depending on the level of professional services the participant elects to use.
