Outlines the displacement and appeal rights of laid off employees. Sets forth the timeframe for an employee to exercise their displacement rights. Provides that laid-off employees exercising their displacement rights shall displace those

employees with the fewest retention points. Provides that provisional employees may not displace certified employees. Outlines that laid-off employees exercising their displacement rights shall not displace an employee whose position/classification requires special minimum qualifications unless the displacing employee possesses those minimum qualifications. Sets forth the rate of pay for an employee following displacement. Outlines a classified employee's appellate rights following the employee's layoff or displacement.
