The rule deals with the order of displacement of employees who are laid-off or displaced as the result of a lay. The amendments to ORC 124.324 in HB 187 removed the restriction that the displacement rights of employees to the classification the employee held immediately prior to the position from which the employee was laid off did not apply to employees of county appointing authorities except for county departments of job and family services. The restriction in the rule is being removed to coincide with the statutory language.
