To make it easier for agencies to evaluate the eligibility of individuals on recall lists with respect to vacant positions that are subject to position-specific minimum qualifications.

The rule contains the parameters and requirements for establishing recall lists as a

result of layoffs and the administration of such lists with regards to individuals that have reinstatement rights back to the agency from which they were laid off. The amendment to the rule allows an agency to obtain information from up to five individuals on a recall list to determine if they meet position-specific minimum qualifications while retaining the concept that the most senior person who meets the qualifications is entitled to the job.
