The rule cotains the parameters and requirements for establishing recall lists as a result of laysoffs and the administration of such lists with regards to individuals that have reemployment rights after a lay-off. The amendment to the rule clarifies how to deal with a tie when placing people on a recall list and allows an agency to obtain information from up to five individuals on a recall list to determine if they meet position-specific minimum qualifications while retaining the concept that the most senior person who meets the qualifications is entitled to the job.
