- 4. The current Paragraph (C) was renumbered as Paragraph (E) and was revised to incorporate the definition of "bid response" found in OAC 123:5-1-12(A)(3).
- 5. The current Paragraphs (D) â (G) were renumbered to Paragraphs (F) â (I), respectively.
- 6. The current Paragraph (H) was renumbered to Paragraph (J) was revised to remove extraneous wording.
- 7. The current Paragraphs (I) â (L) were renumbered to Paragraphs (K) â (N), respectively.
- 8. The current Paragraph (M) was renumbered to Paragraph (O) and revised to clarify employee-requirements for the veteran-friendly business enterprise preference program.
- 9. The current Paragraph (P) has been replaced by 123:5-1-01(S).
- 10. A new Paragraph (P) was added to define "e-Procurement" or "e-Procurement solution."
- 11. The current Paragraphs (N) and (O) were renumbered to Paragraphs (Q) and (R), respectively.
- 12. A new Paragraph (S) was added to replace the current Paragraph (P).
- 13. The current Paragraphs (Q) â (V) were renumbered to Paragraphs (T) â (Y), respectively.
- 14. The current Paragraph (W) was not in alphabetic order, so it was deleted and replaced by 123:5-1-01(AA).
- 15. The current Paragraph (X) was renumbered as Paragraph (Z) and for consistency was revised to incorporate language contained in R.C. 125.01(D).
- 16. Paragraph (AA) was added to replace the current Paragraph (W) so the term "products" would be in alphabetic sequence.
- 17. The current Paragraphs (Y) and (Z) were renumbered to Paragraphs (BB) and (CC), respectively.
- 18. Paragraph (DD) was added to define "qualifications summary," which replaces a definition found in OAC 123:5-1-12(A)(1).
- 19. The current Paragraphs (AA) â (DD) were renumbered to Paragraphs (EE) â (HH), respectively.
- 20. The current Paragraph (EE) is out of alphabetic sequence and has been rescinded and replaced by 123:5-1-01(LL).
- 21. The current Paragraphs (FF) â (HH) were renumbered to Paragraphs (II) â (KK), respectively.
