The rule clarifies that the random selection process for choosing holders to be examined, is not applicable to holders whose records, that are subject to the records review period defined in Chapter 1301 of the Administrative Code, are located outside the state of Ohio. Additionally, the rule lowers the time allotted to holders to gather records requested for an examination by the auditor, from ninety to sixty days, in order to shorten the overall time of an examination.

None. Holders who previously believed they were not subject to an Ohio initiated, involuntary examination, may be audited, resulting in the remittance of monies to the Division. This is not a "cost" to the holder, because the monies never belonged to the holder, but rather the owner for whom the holder held the monies. The amount of any monies to be remitted would be speculative and dependent on the size of the holder, the number of accounts, value of accounts, and whether owners responded to due diligence notices prior to remittance of the monies.
