The 2011 Ohio Fire Code will be available on the State Fire Marshal website with free access. Thus, purchase of a hard copy of the new code is optional and not required.

Section 510 of the OFC establishes requirements for emergency responder radio coverage to be consistent with the International Fire Code (IFC) and a requirement in the Ohio Building Code. Per the International Code Council (ICC), public safety radio systems are converting from analog signaling systems to digital systems. The

focus of these new OFC sections is on the portable radios used by emergency responders inside buildings. "Building construction features and materials can absorb or block the radio frequency energy used to carry signals inside or outside the building." Significant Changes to the IFC, 2009 Edition. Such blockage can result in messages between emergency responders being dropped, placing responders in greater danger.

Section 510 requires that that all buildings (new construction) have approved radio coverage for emergency responders. The requirements apply to both analog and digital. Approved radio coverage is based on the ability of the public safety communication system to transmit a signal inside and outside the building. In lieu of an approved radio system, the fire code official may allow the installation of a wired communication system or no system at all if the fire code official determines it is not needed, for example, some buildings with an area of less than 50,000 square feet.

With respect to existing buildings, the requirements of OFC 510 only apply when the existing wired communication system cannot be repaired or is being replaced, or where a wired communication system is not approved. If this happens, the installation in the building of a radio amplification system is permitted. Finally, if an existing building does not have approved radio coverage, the State Fire Marshal may establish a time frame for compliance with either a wired communication system or a building radio amplification system.

A typical in-building radio amplification system generally costs \$.40 to \$.60 per square foot. Amplification systems designed to support cell phones or mobile devices, wireless data transfer systems, and the like, as part of the signal booster system can cost \$1.00 to \$1.50 per square foot. Significant Changes to the IFC, 2009 Edition. For new construction, the cost of compliance is, generally, a small portion of the overall construction costs. Actual work at a given facility will depend upon a number of variable factors, including the size of the building, labor costs, site-specific needs, and operational needs of the communication system.
