- Rule 8New language was added to clarify existing requirements and/or to be consistent with<br/>the 2009 International Fire Code. In addition, some sections were added to be<br/>consistent with the Ohio Building Code. Finally, the following amended sections contain<br/>a new requirement but have no or de minimis fiscal impact/cost of compliance:
  - Various/805.4 The SFM proposes to eliminate the exemption that rooms with an approved automatic sprinkler system do not need to contain upholstered furniture or mattresses that have been shown to resist ignition by cigarettes. Rather, this code requires all rooms with an approved automatic sprinkler system to contain upholstered furniture or mattresses that have been shown to resist ignition by cigarettes. In addition, OFC 805.4 contains new language that requires upholstered furniture and mattresses introduced in college and university dormitories to be resistant to cigarette ignition.

There is no fiscal impact and a de minimis cost of compliance. The requirement for the items to be cigarette ignition resistant only applies to newly introduced items. Pursuant to the International Code Council, an "overwhelming majority" of upholstered furniture in the U.S. meets the standards set forth in the code. Finally, the standards set forth for mattresses is based on a federal law, 16 CFR 1633, which has been in effect since 2007. Therefore, most, if not all of the relevant items available on the market will already be compliant with standards set forth by the new language.
