This rule is being rescinded so that the SFM can incorporate into the Ohio Fire Code recent changes to the International Fire Code rule concerning Interior Finishes, Decorative Materials and Furnishings. The proposed changes to this rule significantly reorganize the structure of this rule, but do not significantly alter the substance of the rule.
