Page 2 Rule Number: 1301:7-7-09

Prescribes rules for the design, installation, inspection, operation, testing and maintenance of all fire protection systems. Prescribes rules for the certification of individuals and companies to service, test, repair or install fire protection and/or fire fighting equipment.
