

To Be Rescinded1301:7-7-25 Cellulose nitrate (pyroxylin) plastics.

(A) Section FM-2501.0 General

(1) FM-2501.1 Scope: This rule shall apply to the storage and handling of any plastic substance, material or compound with cellulose nitrate as a base, by whatever name known, in the form of blocks, slabs, sheets, tubes or fabricated shapes. In addition to the provisions of this rule, the requirements of rule 1301:7-7-23 of the Administrative Code shall also apply. Cellulose nitrate motion picture film shall comply with paragraph (C)(FM-2503.0) of this rule.

(2) F-2501.2 ~~Permit~~ APPROVAL required: ~~A permit~~ APPROVAL shall be required for the storage or handling of more than 25 pounds (11.5 kg) of cellulose nitrate (pyroxylin) plastics. ~~A~~ APPROVAL~~permit~~ is also required for the manufacture of articles of cellulose nitrate (pyroxylin) plastics, including the manufacture or assembly of other articles involving cellulose nitrate (pyroxylin) plastics.

F-2501.2.1 Nitrate film: ~~A permit~~ APPROVAL shall be required for the storage or handling of more than 25 pounds (11.5 kg) of cellulose nitrate motion picture film, hereafter referred to as nitrate film.

(B) Section FM-2502.0 Fire safety requirements

(1) FM-2502.1 General: The equipment, processes and operations for the storage or handling of cellulose nitrate (pyroxylin) plastics, except cellulose nitrate motion picture film, shall comply with NFPA 40E listed in rule 1301:7-7-44 of the Administrative Code.


(2) FM-2502.2 Smoking: Smoking shall be in accordance with paragraph (L)(F-312.0) of rule 1301:7-7-03 of the Administrative Code.

(3) FM-2502.3 Fire suppression: A fire suppression system shall be provided as required by paragraph (C)(2)(a)(FM-503.2.1) of rule 1301:7-7-05 of the Administrative Code.

(C) Section FM-2503.0 Cellulose nitrate motion picture film

FM-2503.1 General: The equipment, processes and operation of the storage and handling of nitrate film shall comply with NFPA 40 listed in rule 1301:7-7-44 of the Administrative Code.
