Those deferrals were removed pursuant to federal rule revisions that became effective in October 2015, and paragraphs are added to indicate which rules in the chapter are now applicable to those previously-deferred tanks.

Additionally, a paragraph is added to clarify that references in the chapter to "owner and operator" apply equally to both, unless the context dictates otherwise.
