This rule completed its five-year rule revision pursuant to ORC 106.031 in November 2015. BUSTR is now putting the remainder of its rules through the five-year review, and wishes to have all of its rules on the same review schedule. Additionally, revisions to the federal rule on which this regulation is based became effective in October 2015, and BUSTR did not have time to incorporate those revisions at the time; it does so now.

Rule 1301:7-9-05 requires petroleum underground storage tank owners to obtain a certificate of coverage in the State Assurance Fund from the Petroleum Underground Storage Tank Release Compensation Board. Owners must also demonstrate financial responsibility to comply with the deductible coverage requirement.

BUSTR intends to rescind and replace this rule with a new version that keeps the same requirements, but moves much of the content to several appendices. The rule, as it has existed since 1992, consists largely of the precise wording that must be used in various financial mechanisms that may be used by UST owners to demonstrate their ability to pay the deductible. These financial instruments, while currently contained within individual paragraphs of the rule, have their own outline system that does not match the remainder of the rule text. This makes the regulation difficult to follow and hard to find specific provisions. BUSTR believes that by moving the language of each financial instrument to its own appendix, the rule will be much easier to read and understand.

The new rule also makes minor changes based on recent revisions to the equivalent federal rule, including the deletion of a compliance schedule that expired over twenty years ago. Formatting and style changes were also made.
