Costs for loading, shipping and disposal of petroleum contaminated soils at a licensed disposal facility are approximately \$40.00 to \$50.00 per cubic yard. The cost for treatment of petroleum contaminated soils as an alternative to shipping and disposal can vary widely. Part of the pre-approval process will consist of an assessment of any cost savings over disposal that the treatment will provide.
