This rule contains definitions of terms used in the Revised Code and in the rules contained in this package. This rule is being amended to remove a reference to an obsolete date. The rule requires that "net worth," as used in section 1321.37 of the Revised Code be determined by using generally accepted accounting principles. It limited this to those principles in effect in 2008, and that limitation was removed to allow current generally accepted accounting principles to be used when determining net worth.
