This rule clarifies how to calculate the amount of "liquid assets." Pursuant to R.C. 4727.03(A)(4), licensees must show liquid assets in a minimum amount of one hundred thousand dollars at the time of applying for initial licensure and demonstration of the ability to maintain the liquid assets at a minimum amount of fifty thousand dollars for the duration of holding a valid pawnbroker's license. The rule sets forth a broad method for calculating liquid assets to assist small businesses in meeting this statutory requirement. The liquid assets requirement is mandated by statute and protects consumers by ensuring that registrants have a sufficiently capitalized business.
