This is a proposed new centralized definitions rule. In paragraph (A), it defines

"liquid assets," which definition was moved from the proposed rescinded rule 1301:8-5-01. In paragraph (B), the rule gives a new definition for the phrase "each pawn or purchase" from 4728.08(B). In paragraph (C), "redemption" is defined, which was previously defined in 1301:8-5-08. The term "redeem" is now for the first time included in the definition of "redemption." In addition, the rule in paragraph (D) defines "employee," which was previously defined in 1301:8-5-09, and in paragraph (E) defines "verify," which was previously defined in 1301:8-5-04. Paragraph (F) defines the term "pawn date."
