This rule prohibits licensees from purchasing personal property in such a manner as to circumvent the recordkeeping requirements set forth in Chapter 4727. of the Revised Code, and requires them to document the acquisition of all property held for sale, and specifies the acceptable methods for that documentation. This rule is being amended to clarify that the pledgor must sign all of the forms referenced in paragraph (B) of this rule, and to require the documentation of certain information when a pawn is redeemed. This rule is being amended in order to clarify the requirements, and also to remove language that is duplicitous with Chapter 4727. of the Ohio Revised Code.
