Amendments to Paragraphs (A) and (B) require the Board to set the Medicare B reimbursement at an amount not less than \$96.40 and prohibits the Board from

reimbursing any more than the recipient is actually paying for Medicare B. New paragraph (F) will permit OPERS to suspend the premium reimbursement if the benefit recipient does not certify the amount he or she pays for coverage.
