This rule defines the "basic premium" as an amount charged to an individual enrolled in medicare part B coverage whose modified adjusted gross income is below \$80,000 for the last taxable year, as determined by the Centers for Medicare

and Medicaid Services. It also clarifies that the Medicare B reimbursement will be effective after OPERS has received evidence of the coverage and certification from the benefit recipient.
