ORC Chapter 1513. requires a coal mining permit to mine coal in Ohio. ORC section 1513.02(A)(8) requires the Chief of the Division of Mineral Resources Management to "Establish programs and adopt rules and procedures governing terms, limitations, and conditions for the use of diesel equipment in an underground coal mine." Appropriate use of diesel equipment would become one of the conditions placed on an underground coal mine permit.

This rule requires that the Chief approve the results of procedures used to establish baseline exhaust emissions values prior to their being implemented for diesel engines or diesel equipment in an underground coal mine.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? N_0

This rule does not impose a penalty, but state law imposes penalties on persons who do not obey the State's coal mining laws. See Ohio Revised Code sections 1513.17 and 1513.99.
