RC 153.71 allows a public authority to adopt, amend, or rescind rules under Chapter 119 of the Revised Code to implement RC 153.66 to 153.70. Currently, Rules 153:1-1-01 to 153:1-1-06 govern the selection of professional design services for the State of Ohio. However, with the passage of H.B. 153, these rules need to be rescinded and will be replaced with two new rules. One rule for qualifications-based selection of professional design firms and one rule for prequalification of professional design firms. Because of the changes, Rule

153:1-1-02 must be rescinded and will be replaced with new Rule 153:1-1-02.

This rule sets forth the prequalification requirements for design professional firms seeking to provide services to public authorities. Because of significant additional factors that have been added to Chapter 153 of the Revised Code, this rule is being replaced.
