This proposed new rule restates division (A) of section 119.03 of the Revised Code regarding public hearing notices. The rule also says that ODA shall provide a copy of the notice to a person who is affected by rule proposal free of charge, whether electronically or by hard copy. It also says that ODA shall provide an electronic copy of the notice, free of charge, to any person not affected by the rule, but may require such a person to pay for the costs of distributing a hard copy of the notice.

Other state agencies have adopted comparable rules that restate section 119.03 of the Revised Code. (E.g., the Ohio Attorney General's rule 109-1-01 of the Administrative Code, the Ohio Secretary of State's rule 111-7-01 of the Administrative Code, and the Ohio Department of Developmental Service's rule 122-1-01 of the Administrative Code.)

ODA's proposed amendments to this rule involve spelling out "Ohio department of aging" before using the acronym "ODA," replacing some occurrences of the pronoun "it" with "ODA," and replacing semi-colons with periods.
