ODA adopted Chapter 173-13 of the Administrative Code to comply with R.C. §1347.15, which requires each state agency to adopt rules to regulate employee handling of confidential personal information (CPI). ODA reviewed this the current version of this rule as part of its 5-year review of Chapter 173-13 of the Administrative Code and now proposes to rescind the current rule and to replace it with this proposed new rule. The differences between the current rule and ODA's proposed new rule are not substantive.

This proposed new rule will establish procedures for accessing CPI.

This proposed new rule differs from the current rule in the following non-substantive ways:

- 1. "Confidential personal information" appears at the beginning of the proposed new rule's title. Because the Ohio Administrative Code does not have chapter titles and because many readers find rules by internet searches, adding the phrase will give context to the rule (in the absence of a chapter title) and optimizes the title for internet searches.
- 2. "CPI" replaces occurrences of "confidential personal information," which shortens the rule.
- 3. "Requirements" replaces "criteria."
- 4. "Before" replaces "prior to."
- 5. "Employee" replaces occurrences of "individual" that refer to an employee.
- 6. The active voice replaces occurrences of the passive voice, which complies with the Legislative Service Commission's Rule Drafting Manual.
