ODA adopted Chapter 173-13 of the Administrative Code to comply with R.C. §1347.15, which requires each state agency to adopt rules to regulate employee handling of confidential personal information (CPI). ODA reviewed this rule as part of its 5-year review of Chapter 173-13 of the Administrative Code and now proposes to adopt this new rule to replace a substantially-similar rule of the same number.

7. **Summarize the rule's content, and if this is an amended rule, also summarize the rule's changes.**

This proposed new rule will establish procedures for accessing CPI.

This proposed new rule differs from the current rule in non-substantive ways, including the following:

1. "Confidential personal information" appears at the beginning of the title. Because the Ohio Administrative Code does not have chapter titles and because many readers find rules by internet searches, adding the phrase will give context to this rule (in the absence of a chapter title) and optimizes the title for internet searches.
2. "CPI" replaces 19 occurrences of "confidential personal information," which will shorten this rule.
3. "Requirements" replaces an occurrence of "criteria."
4. "Before" replaces "prior to" (just as ODA would replace "posterior to" with "after").
5. "Person" replaces 11 occurrences of "individual" that refer to the subject of CPI (and represents the "P" in "CPI").
6. The active voice replaces occurrences of the passive voice in paragraphs (A), (B), (C)(1), (C)(2), and (C)(3) of this rule, which complies with the Legislative Service Commission's requirement for the active voice in its Rule Drafting Manual.
