ODA proposes to make non-substantive amendments to this rule, including the following:

- 1. Add "Confidential personal information" to the beginning of the title. Because the Ohio Administrative Code does not have chapter titles and because many readers find rules by internet searches, adding the phrase will give context to this rule (in the absence of a chapter title) and optimizes the title for internet searches.
- 2. Replace occurrences of "confidential personal information" with "CPI" to shorten this rule.
- 3. Replace occurrences of "individual" that refer to the subject of CPI with "person" (the "P" in CPI).
- 4. Replace the occurrence of "ODA employee" with "employee."
