This proposed new rule will define terms used throughout the chapter.

Because ODA's proposed amendments to the current version of this rule would amend approximately 50% of that rule, ODA proposes to adopt this new rule to replace the current rule in compliance with §4.3.1 of the Legislative Service Commission's Rule Drafting Manual. ODA's proposed new rule will achieve the following in comparison to the rule that it will replace:

- 1. Refer to definitions in the Ohio Revised Code for the following terms rather than continue to repeat those definitions in this rule: "community-based long-term care services," "long-term care facility," "personal care services," "resident," and "recipient."
- 2. Delete definitions for the following terms, which do not appear in this chapter: "client," "designated entity," and "provider orientation."
- 3. Define the following terms: "business day" and "complaint."
- 4. Replace the defined term "affiliation" with "affiliated."
- 5. Replace the defined term "clock hour" with "hour."
- 6. Define "ODIS" to include the system that replaces ODIS so that references to ODIS in this chapter will remain relevant if ODA replaces ODIS with a new system.
- 7. Simplify the definition for the term "Older Americans Act" so that it refers only to the act's codification in the United States Code.
- 8. Remove the unnecessary use of the regulatory-restriction word "require" from definitions of the terms "complex complaint" and "long-term care facility" to comply with R.C. §121.951.
- 9. Make other non-substantive improvements to this rule, including placing all defined terms in alphabetical order and replacing the passive voice with the active voice to comply with §5.8.6 of the Rule Drafting Manual.
