ODA and the SLTCO (we) adopted OAC Chapter 173-14 (this chapter) to establish and operate a state long-term care ombudsman program as required by ORC§173.01; 42 USC 3027, 3058g; and 45 CFR 1321.11 and Part 1324. We also adopted this chapter

to carry out the provisions of ORC Chapter 173 pertaining to ombudsman programs as required by ORC§173.02.

As part of this chapter, we propose to adopt this rule to establish the required curriculum for candidates' professional development.

We reviewed every rule in this chapter top to bottom, as ORC§106.03 requires us to do no less often than once every 5 years. In doing so, we considered any necessary amendments to implement the following new laws:

- (1) Effective February 11, 2015, the U.S. Dept. of Health and Human Services, Administration on Aging (AoA) and Administration for Community Living (ACL) jointly adopted 45 CFR Part 1321 to regulate long-term care ombudsman programs. AoA and ACL subsequently amended their rules and renumbered them as 45 CFR Part 1324.
- (2) Effective April 19, 2016, the Older Americans Act Reauthorization Act of 2016 amended §§ 711 (42 USC3058f), 712 (42 USC3058g), and other sections of the Older Americans Act of 1965.
- (3) Effective September 29, 2017, Am. Sub. House Bill No. 49 (132nd G.A.) amended ORC §§ 173.14, 173.15, 173.17, 173.19, 173.20, 173.21, 173.22, and 173.24.

We now propose to adopt this new rule to replace the current rule, which we are simultaneously proposing to rescind.

## 7. Summarize the rule's content, and if this is an amended rule, also summarize the rule's changes.

This proposed new rule will establishe the required curriculum for candidates' professional development.

Compared to the current rule this new rule will replace, the new rule contains our "amendments" to achieve the following:

- (1) Remove the organization and operations of providers from the required topics to cover in an overview of the long-term care system.
- (2) Replace "the aging process and attitudes on aging" as a required topic for an overview of the long-term care system with "aging and disability."
- (3) Replace aging networks as a required topic for an overview of the long-term care system with aging "and disability" networks.

(4) Replace a required overview on "complaint resolution skills with an emphasis on advocacy, negotiation, empowering consumers, and follow-up activities" with "complaint-resolution skills and follow-up activities, with an emphasis on advocacy, negotiating, and empowering consumers."

- (5) Replace "ombudsman ethics and alternative decision-making" as required topic for the initial 40 hours of professional development with "consumer decision-making principles."
- (6) Add systems advocacy and Ohio ethics law to the list of topics required for the 60 additional hours of professional development.
- (7) Add to the professional development for ombudsman program directors a requirement to cover, not "management skills," but "management of core ombudsman services and data"; not "fund raising," but "fiscal management."
- (8) Remove the following topics from the required professional development for ombudsman program directors: administering the program, budget development, and use of ombudsman data as a management tool.
- (9) Delete the paragraph permitting regional programs to request permission from the SLTCO to cover substitute curricula.
- (10) Make improvements to the rule's word choice, organization, and punctuation.
