ODA proposes to amend this rule to replace two occurrences of "submit to the SLTCO" with "save electronically in the ombudsman registry" to remove a word ("submit") that implies a requirement for an outdated mode of communication of filing paperwork.

ODA also proposes to make non-substantive improvements to this rule.
