Because ODA's proposed amendments to the current version of this rule would amend approximately 50% of that rule, ODA proposes to adopt this new rule to replace the current rule in compliance with §4.3.1 of the Legislative Service Commission's Rule Drafting Manual. ODA's proposed new rule will achieve the following in comparison to the rule that it will replace:

- 1. Reduce the unnecessary use of the regulatory-restriction words "shall" and "may not" in this rule to comply with R.C. §121.951.
- 2. Move the last sentence of paragraph (B)(2) of the current rule into a paragraph of its own on conflict of interest.
- 3. Replace "volunteers" in paragraph (B)(6)(c) of the current version of this rule with "representatives" in paragraph (B)(7)(c) of this proposed new rule.
- 4. Delete the requirements in paragraphs (B)(6)(d) and (B)(6)(e) of the current rule for the sponsoring agency to develop policies and procedures on conflicts of interest since rule 173-14-15 of the Administrative Code and federal rules already establish standards for conflict of interest.
- 5. Make additional non-substantive improvements to this rule, including replacing the passive voice with the active voice to comply with §5.8.6 of the Rule Drafting Manual.
