2. Replace "SLTCO's quality improvement coordinator" in paragraph (C)(2) of this rule with "The SLTCO's designee."
3. Replace "ombudsman responding" in paragraph (D) with "investigator who responds."
4. Combine paragraph (D)(8) of this rule into paragraph (D)(7) of this rule.
5. Add the following as a new paragraph (D)(8) of this rule: "Consider whether decertification is appropriate under rule 173-14-27 of the Administrative Code."
6. Make additional non-substantive improvements to this rule.
