- 1. Replace the definition of "AAA," "Long-term care consultation program administrator," personal care services," "PSA," and "skilled nursing care" with references to places in the Revised Code that define those terms.
- 2. Add a definition for "community living arrangement."
- 3. Replace the citation concerning "long-term care consultation program" from "173.42" to "173.351."
- 4. Place the definition of "provider" in the singular.
- 5. Replace "pursuant to" with "under."
- 6. Replace "As used in Chapter 173-35 of the Administrative Code:" with "Definitions for this chapter:"
- 7. Replace "The rules of chapter 173-35 of the Administrative Code govern" with "This chapter governs."
- 8. Add the word "Introduction" to the beginning of paragraph (A) of the rule.
- 9. Delete "as defined in this rule" from the definition of "facility" because ODA is also defining that term in this short rule. The words are unnecessary.
