ODA is proposing to adopt this proposed new rule as a replacement for a rule of the same number. This rule proposal is part of a larger package of rule proposals for the RSS program. As stated in greater detail in the public hearing notice, ODA is proposing to rescind rules 173-35-04 and 173-35-05 of the Administrative Code, and to replace the remaining rules of Chapter 173-35 of the Administrative Code with new rules. In doing so, ODA's goals are to:

- 1. Comply with the review required under section 119.032 of the Revised Code.
- 2. Comply with Governor Strickland's Executive Order 2008-04S: "Implementing Common Sense Business Regulation," which requires all state agencies to write easier-to-read and easier-to-comprehend rules to promote transparency in state regulations.
- 3. Present a more complete list of eligibility criteria in rule 173-35-02 of the Administrative Code.
- 4. Comply with Am. Sub. H. B. No. 1 (128th G. A.), which now uses money-follows-the-person language and sets the current rates for the program.
- 5. Eliminate the rule that regulates case managers.
- 7. If the rule is an AMENDMENT, then summarize the changes and the content of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

In comparison to the rule that ODA is proposing to replace with this rule, ODA is proposing to:

- 1. Replace the current title of the rule ("Eligibility") with "Eligibility criteria." This makes the proposed new rule consistent with other ODA rules that present eligibility criteria.
- 2. Add, in paragraph (A)(1) of the proposed new rule, the federal eligibility criterion that requires the individual live in Ohio. Although this criterion does not appear in the current rule, it is not a new criterion. Federal law already requires Ohio residency.
- 3. Arrange the living arrangements under paragraph (A)(2) of the proposed new rule in alphabetical order.
- 4. Add, in paragraph (A)(3) of the proposed new rule, an eligibility criterion that requires the individual to cooperate in the enrollment process, including requiring the individual to apply for Medicaid and to select a living arrangement that ODA's designee determines meets the individual's needs.
- 5. Specifically cite JFS' rule on financial eligibility criteria in paragraph (A)(4) of the proposed new rule.
- 6. Add a reference to paragraph (A)(5) of the proposed new rule that says in what rule the Ohio Department of Job and Family Services defines a protective level of care. In making this amendment, ODA also made this criterion similar to the wording of a corresponding criterion in rule 5101:1-17-02 of the Administrative Code, thereby harmonizing ODA's RSS rules with JFS' RSS rules.

7. Replace the second use of "the individual" in paragraph (A)(6) of the proposed new rule with "he or she."

- 8. Replace "in accordance with" in paragraph (A)(6) of the proposed new rule with "under."
- 9. Add, in paragraph (A)(6) of the proposed new rule, a reference to the section of the Ohio Revised Code defines "skilled nursing care." This is the only use of "skilled nursing care" in the rules of Chapter 173-35 of the Administrative Code, so placing this definition here eliminates any need to define the term in rule 173-35-01 of the Administrative Code.
- 10. Replace, in paragraph (A)(8) of the proposed new rule, "granted by the United States secretary of health and human services and under Section 1915(c) of the "Social Security Act," 49 Stat. 620 (1935), 42 U.S.C.A. 1396n, as amended" with the word, "program."
- 11. Add, in paragraph (A)(10) of the rule, the eligibility criterion that requires the individual to be an adult. This harmonizes ODA's rules with division (B) of section 173.35 of the Revised Code, which says the person needs to be an adult.
- 12. Add language to paragraph (B) of the proposed new rule that incorporates the exception of division (G) of section 173.35 of the Revised Code into the rule and cites the legislation that authorized this exception.
