The CDJFS uses the FNS to calculate an individual's financial eligibility for the RSS program as specified in Chapter 5101:1-17 of the Administrative Code.
- (C) The allowable fee for a particular <u>community</u> living arrangement is the amount an RSS resident pays to a facility. The CDJFS uses the allowable fee to calculate the amount of supplement an RSS resident receives based upon the resident's living arrangement as specified in Chapter 5101:1-17 of the Administrative Code.
