This rule that ODA is proposing to amend introduces Chapter 173-38 of the Administrative Code and defines terms used in the chapter. The chapter regulates the Medicaid-funded component of the Assisted Living Program.

ODA is proposing to amend the rule in the following ways:

- 1. ODA is proposing to update references the rule's "authorized by" and "rule amplifies" sections to reflect the reorganization of sections of the Ohio Revised Code by H.B.59.
- 2. ODA is proposing to list the revision dates of the forms cited in the rule and to state where the reader of the rule may readily find those forms.
- 3. ODA is proposing to add "that" to a few sentences that lacked it.
- 4. ODA is proposing to replace references to ODJFS rules with references to corresponding ODM rules. This is because H.B.59 transformed the Medicaid operations inside of ODJFS into a state department of its own.
