This rule establishes the requirements to become, and to remain, an ODA-certified provider of non-emergency medical transportation.

ODA proposes to amend this rule to replace the requirement of the provider to collect the driver's signature to verify that each trip was provided with a requirement to collect a unique identifier of the driver to do the same. ODA defines "unique identifier" in rule 173-39-01 of the Administrative Code. ODA also proposes to delete the last sentence of paragraph (*b)(4)(a) of this rule because it unnecessarily repeats part of the definition of "unique identifier" in rule 173-39-01 of the Administrative Code.

ODA also proposes to make non-substantive improvements to this rule.
