The Ohio Department of Medicaid (ODM) proposes to incrementally adopt one chapter of rules (OAC Chapter 5160-44) that will become the single set of service standards for providers serving individuals through all Medicaid waiver programs operated by the Ohio Department of Aging (ODA) and ODM. This is part of ODM's larger strategy to develop a uniform set of rules to beneï¬t providers who serve individuals enrolled in multiple Medicaid waiver programs.

This proposed new rule will establish the requirements for ODA-certiï¬ed providers of community transition. ODA's proposed new rule will require ODA-certiï¬ed providers of community transition to comply with (1) the requirements in 173-39-02 for every certiï¬ed provider (e.g., conducting background checks and complying with state and federal laws and regulations governing individuals' conï¬dentiality) and (2) speciï¬c requirements for providing community transition in ODM's proposed new 5160-44-26 (e.g., service veriï¬cation).
