ODA is proposing this new rule to comply with section 173.431 of the Revised Code as enacted by Am. Sub. H. B. No. 1 (128th G. A.), which authorizes a new service called the "enhanced community living service" contingent upon the approval of a requested Medicaid waiver for the PASSPORT program that would allow ODA to offer the service to eligible consumers in approved settings.

This proposed new rule defines "enriched community living service," lists the minimum requirements for a provider of an enhanced community living service, and provides the unit of enhanced community living service and a link to another rule that establishes the maximum rates allowable.
