ODA proposes to adopt this new rule as part of a larger rule project for Chapter 173-39 of the Administrative Code. The larger project has 5 goals: (1) create

reciprocity for the Medicaid waiver programs, (2) simplify the definitions and conditions-of-participation rules, (3) implement HB59's amendments, (4) implement training requirements for consumer-directed providers, and (5) make other updates. Please see the details under question #1 of the BIA for more information.

ODA proposes to rescind the rule and, simultaneously, to adopt a new rule of the same number. Compared to the rule that ODA is proposing to rescind, in the new rule, ODA is proposing to (1) create reciprocity for the Medicaid waiver programs, (2) simplify the conditions-of-participation rule, (3) implement training requirements for consumer-directed providers, and (4) make other updates. The choices home care attendant service in this rule differs from the home care attendant service in rule 173-39-02.24 of the Administrative Code.
